We join forces and stand shoulder to shoulder with all those who's Civil and Constitutional rights where or are at issue as a result of these implementations.





## Deputy District Attorney Susan Irene Etezadi wins the San Mateo County Superior Court judge's race

San Mateo, CA – (June 8, 2006) The Iranian American Lawyers Association congratulates Deputy District Attorney Susan Irene Etezadi in her winning the San Mateo County Superior Court judge's race last Tuesday night.



Veteran prosecutor Susan Etezadi beat out former coworker and current defense attorney Lisa Maguire for a rare judicial seat, making her the first Iranian-American judge in the San Mateo county and one of the few judges chosen by voters.

Susan Etezadi received her bachelor's degree from University of California, Davis and graduated from University of San Diego Law School in 1983. She spent 21 years with the District Attorney's Office and during her career, has prosecuted 71 jury trials and more homicides than any other woman in the San Mateo county and in January 2007, she will assume the seat on the Superior Court bench currently held by Judge John Schwartz, who retires in Au-

gust after 20 years of service.

"It makes me very humble and proud that the people of San Mateo County voted for me. The courts belong to the people and a judge works for the public, the public has spoken. I am honored," Etezadi said.

Iranian-American Judges currently serve on the bench of the Los Angeles (Honorable Soussan Bruguera) and San Bernardino County Superior Courts (Honorable Shahla Sabet) as well as Federal immigration courts (Honorable Gita Vahid-Tehrani) in Los Angeles. Iranian American attorneys also occupy significant positions in the local District Attorney's Offices, Public Defender's Offices, the California Attorney General's Office and the U.S. Attorney's Office.

## Los Angeles Multi-Cultural Advisory Committee (MCAC) Town Hall Meeting April 8, 2006

Los Angeles – (April 2006)

Co-hosted by the FBI's Multi-Cultural Advisory Committee (of which Iranian American Lawyers Association is a member and co-founder organization) on Saturday, April 8, 2006 at the Exposition Park Community Center in Los Angeles .



FBI supervisors and Multi Cultural Committee members addressed the audience's questions and concerns. Saturday's Town Hall meeting at the Exposition Park Community Center near USC was the first of what organizers have planned to be a series of meetings in Southern California.

The FBI-LA, (MCAC) is an independent body/assembly of non-profit community based organizations, groups and associations who represent the diversified people of Southern California and its mission statement reads:

"The Multi-Cultural Advisory Committee (MCAC) endeavors to create an environment to facilitate dialogue and enhance the relationship between the FBI and the Community which is based on mutual respect, understanding, and the protection of Constitutional rights and civil liberties."

As also reported in Los Angeles media, P. Patrick Ashouri, President of the Iranian American Lawyers Assn., and the advisory committee's spokesperson told the audience, that, "As a lawyer's association, we determined that the protection of the constitutional and civil rights as well as the unconditional right to counsel if addressed, would bring a balance which we felt would be necessary before we could play an effective role in this relationship to build and enhance dialogue and relationships between law enforcement (FBI) and the community".

Mr. Ashouri added: "We are the Middle eastern, the Asian and



South Asians, the Pakistanis, Indians and Iranians. We are the Latinos, Sikhs and Egyptians. So we tried to have the committee be a representative of Southern California's diversity a diversity and make up that often is spoken about by the rest of the Nation as an example of the America's melting pot.

It took a lot of time effort and energy to covenant what we all agreed to thus far. This is a very unique and powerful committee. It draws its power and energy from the unity of its members. We continue to expand its reaches and horizon and collectively work on protecting it and making it stronger and more diversified and representative of our community."

Mr. Ashouri added:

"We got together back in 2004 out of growing and increasing concerns regarding effects and implementations of post 9-11 federal laws and those who enforce it.

We went to the FBI as co-equals and suggested a forum which is open to all representative groups. It was agreed, and the first MultiCultural Advisory Committee was formed in 2004 and has been operating ever since."

Mr. Ashouri continued to summarize the committee's activities of advising on cultural sensitivity issues, about practices of field agents regarding various religious beliefs and local procedures which were changed to adopt to those concerns, unconditional right to counsel in voluntary interviews, clarification on FBI's name and

background check process and procedures, the ramifications of the Patriot Act and its application in FBI's local practices, hosting various meetings for key speakers from various State and Federal departments including, Debra Yang (U.S. Attorney, CA-Central District), Bill Lockyer (CA, Attorney General), Ana Hinojosa (US Customs and Boarder Protection), and USCIS.

#### Other news

#### Interview with Dan Sutherland of DHS office of Civil Rights

Los Angeles - (March 2006) IALA also a member of the DHS community outreach committee which

started in 2004, interviewed Dan Sutherland, in charge of the office of Civil Rights & Civil Liberties of the Department of Homeland Security and in charge of the outreach program on KRSI Radio in March 2006.

In this interview with P. Patrick Ashouri, Mr. Sutherland elaborated on the governments readiness to prosecute all hate crimes including that which may be targeted against the Iranian American Community and encouraged callers and listeners to document and report any incidences of alleged hate crime or civil rights violations immediately.

The outreach committee meets regularly with representatives of DHS including ICE, TSA, CBP and USCIS among others, to update contacts, learn of new procedures in various offices and inform the authorities of local issues, concerns and challenges.



IALA has continually advocated for due process and unconditional right to counsel for individuals who are questioned or detained and demanding equal and proportional access and representation by the Community to government assemblies or forums.

## Fifth Circuit remands case to the BIA to rule on the merits

Los Angeles - ( February 2006)

The issue in <u>Torabi v.</u>
<u>Ashcroft</u>, Fifth Circuit Case
No. 04-60123, unpublished,
was whether the Board of
Immigration Appeals (BIA)
abused its discretion in denying the alien's motion to
reopen, based on her statutory eligibility to adjust to
permanent resident status.

Timing was critical in this case. While the alien's appeal of a BIA denial was on timely appeal to the Fifth Circuit, and *only days after* the expiration of the 90-day

deadline to file a motion to reopen before the BIA, the Immigration Service approved the alien's I-140 Immigrant Petition.

Petitioner filed a Motion to Reopen with the BIA, citing this new evidence and sent a request to the Fifth Circuit to stay proceedings while the motion was adjudicated. The BIA denied the motion solely on the basis of timeliness, and a Status Report was sent to the Fifth Circuit informing them of the decision and asking the Court to review this new decision.

## Fifth Circuit remands case to the BIA to rule on the merits

The Court ordered the matter "carried with the case", resumed the briefing schedule, and ordered the parties to appear for oral argument before a three-judge panel on October 4, 2005. The issue was successfully argued by Zohreh Mizrahi, former IALA president (1997) and lead immigration attorney of Law office of Mike S. Manesh. On January 30, 2006, the Court issued its decision with the following notable findings:

- 1- The 90-day limitations period for filing motions to reopen under 8 C.F.R. §1003.2(c)(2) is regulatory, not jurisdictional, and the doctrine of equitable tolling may be applied.
- 2- The Courts have discretionary authority to order the Board of Immigration Appeals (BIA) to consider the merits of an adjustment of status claim based an alien's Immigrant Petition which was approved <u>after</u> the ninety-day deadline to file a Motion To Reopen before the Board.
- 3- A Status Report timely filed as required by court order, which is filed within 30 days of the denial of a subsequently filed Motion to Reopen and which seeks review of *that* denial, "is both a constructive and timely petition for review."

The Fifth Circuit remanded the case to the BIA solely to rule on the merits of the alien's eligibility for adjustment of status. The Court held the merits of the alien's claims for asylum, withholding of removal and relief under the U.N. Convention Against Torture, in abeyance pending the outcome of the BIA's consideration. The government subsequently filed a Petition for Rehearing, but it was denied.

On remand, the BIA received supplemental briefs from both parties and the matter is currently pending.

PLEASE NOTE THAT Pursuant to 5TH CIR. R. 47.5, the court has determined that this opinion should not be published and is not precedent except under the limited circumstances set forth in 5TH CIR. R. 47.5.4. However, petitioner's counsel's office has been contacted by other practitioners who plan to urge the Court to publish the case.



The judiciary has attempted, over the past few decades, to define who is citizen, immigrant, immigrant alien, documented alien or undocumented alien and, has categorized numerous administrative and legal procedures to obtain various classifications under Immigration and other Federal law.



As a member of the aforementioned population, I can only believe that as long as our "pledge" and the law that grids it, stand for the equal protection, liberty and justice for all, America shall provide an unprejudiced safe harbor for those who flee oppression and dictatorship. We émigrés are seeking to have a secure home to raise our families, contribute to society and participate in advancing humanity, and its aspiration of mutual understanding and respect. Some attendees used the Town Hall meeting to share their experiences. For instance, an American grandmother of Iranian descent, expressed fear for herself and her family. "I am a U.S. citizen, have been here for over 25 years and always paid my taxes. I am worried about my family, my four

children and six grandchildren". She went on to say she is sometimes afraid to even go out shopping because her hair covering identifies her as a non-mainstream "What is the solution for us?"

J. Stephen Tidwell, Assistant Director in charge of the Los Angeles FBI office, said that the Bureau has always investigated and helped local authorities in cases of hate crimes and shared examples of their recent investigations and cooperation.



He encouraged everyone to contact the FBI or their community based organization members of the advisory committee in case of any concerns or issues whether it involves the FBI directly or where the FBI can assist in addressing the issue.
